#### Small Business Assistance Program

This program conducts research on injury prevention and increases awareness of injury prevention activities among businesses with fewer than 50 employees. #### Occupational Exposure Banding

NIOSH recently released a [chemical management strategy](#) that quickly and accurately assigns chemicals into categories, or "bands," to protect workers on the job. Occupational exposure banding is a voluntary process that assigns each chemical to a category based on its toxicity and any negative health outcomes associated with exposure to it.

## Participation in Workplace Health Promotion Programs

---

A new study by researchers at NIOSH found that close to 47% of workers have access to workplace health promotion programs, and among those with access, only 58% of workers take advantage of them. Read more about this research on the [NIOSH website](#).

### Redesigned Whistleblower Website

---

OSHA recently redesigned the [Whistleblower Protection Program's website](#). The whistleblower program protects employees from retaliation for reporting workplace safety violations. The new homepage uses video to highlight the covered industries. The improved site allows visitors to easily access information on protected activities, filing deadlines, and resources.

### Fall Protection Training

---

Two universities recently added free training programs to help protect construction workers from fall hazards. The [University of Tennessee training program](#) offers three modules on OSHA's role in workplace safety, health and safety standards affecting construction workers, and preventing common types of falls at construction sites. Meanwhile, the [University of Florida training program](#) uses software to present 360-degree panoramas of construction scenarios to test trainees' skills at identifying fall hazards.

## New Construction Health Booklet

---

The American Industrial Hygiene Association (AIHA) issued a guidance booklet, [Focus Four for Health: An Initiative to Address Four Major Construction Health Hazards](#). The 54-page publication, developed by AIHA's Construction Committee addresses these four common construction industry health hazards:

- Manual material handling.
- Noise.
- Air contaminants.
- High temperatures.

## Firefighter Fatalities

---

The National Fire Protection Association (NFPA) report on firefighter fatalities in the U.S. found there were 64 on-duty deaths in 2018. Of those, 25 were at fires, 40% were sudden cardiac deaths, three were vehicle-related, and one was a murder of a firefighter responding to a call. Read the entire report at the [NFPA website](#).

## Preventable Injury-related Deaths

---

Poisoning was the leading cause of preventable death in 2017 according to the National Safety Council's Injury Facts state data. The report says the opioid drug overdose epidemic was the primary driver. Ohio had the second highest rate of poisoning in 2017. State data from 2017 is available on the [Injury Facts website](#).
